

Seasonal Site Lottery at Tuft's Bay

Information Sheet 2026

Seasonal campsite rentals are available at Tuft's Bay Campground. Due to the high demand and for fairness, the sites will be distributed in a lottery-type process. *** Seasonal Applications will open Jan 1 2026 and closes Jan 31 2026*** The draw will take place on Monday, February 9 @ 2:00pm, the Draw will be recorded and then posted on the Tufts Bay Campgound Facebook page and the successful winners' names will be posted on the Village website www.villageofelbow.com under the Receation & Atractions tab then Tufts Bay Campground and on the Village of Elbow Facebook page. Successful entries will be contacted by the Tufts Bay operators on Tuesday February 10, 2026 for campsite selection. (See below for more details)

- TO ENTER: Visit TUFTSBAYCAMPGROUND.com or www.villageofelbow.com (under the Receation & Atractions tab then Tufts Bay Campground and fill out the Tufts Bay lotto application). Only one application per family/household is permitted. Family is generally defined as 1 or 2 parents(guardians) and children under 18 years of age.
- Campsites are NON-TRANSFERABLE
- Submitting multiple applications under different names, applying on behalf of someone else, or completing an application for site occupants other than themselves will result in forfeiture of the campsite and deposit, as well as disqualification from the current and next season's draw.
- <u>Deadline to enter</u>: SATURDAY JAN 31, 2026 at 11:00 PM (EST time for e-transfers to process)

 \$500.00 deposit required at time of application. Please e-transfer ONLY your deposit to: elbow2@sasktel.net (no password required).

 Unsuccessful applicants will have their deposit refunded once all 25 campsites have been filled.

- Completed entries (entry form & deposit received) Jan 31 2026 will have their names entered into the Seasonal Draw.
- THE LOTTERY DRAW: All names entered in the lottery will be drawn, but only the first 25 will be eligible to pick a site on selection day. The names drawn after the first 25 will be put on a "Waiting List"
- If there are more than 25 applicants then 2 draws will take place. First being who gets chosen for the 25 Seasonal Sites, and 2nd draw will be the order that you will get to choose your site. We will use an electronic Spin Wheel and post the draw on Facebook.
- <u>Campsite selection</u> will begin at 10:00am on Tuesday Feb 10, 2026. The Tufts Bay Operators will start calling the first successful entry at 10:00am and will continue down the list in 15 min increments. If you are not able to answer our phone call, then please let your proxy contact know that we will be calling. If we cannot successfully reach either contact, then you will move to the end of the list and be phoned one more time. If there is still no answer, you forfeit your campsite for the 2026 season and we will contact the first person on the "Waiting List".

PLEASE NOTE THE FOLLOWING IMPORTANT INFORMATION:

- All vehicles, recreational vehicles, boats and trailers must be contained within the individual campsites or parked directly adjacent to the site.

 Any visitors to the campsite and their corresponding vehicles must comply with the same rules. Any empty boat trailers or other trailers will need to be parked on the top of the hill by the dumpsters to allow more parking space for the Campground so please have a hitch lock for those.
- Sites 2-8 and 26-29, have restricted access to parking and subject to the same rules as other campers. If needed, additional parking is available in the common areas of the campground, at the entrance to the beach access side of the campground or at the top of the hill as you enter the campground proper.
- You are not allowed to plug anything into pedestal except camper. No outside appliances e.g freezers allowed to be plugged in.
- When vacating the campsite at the end of the season, the permit holder must remove all personal property and restore the campsite to its original condition. If the campsite is **not** restored to its original condition, the Operators reserve the right to restore the campsite and charge the campsite holder associated costs for restoration of the campsite.
- Full balance payment of site fees for your selected campsite is due Saturday Feb 28, 2026. The remainder to the Campsite fees must be e-transferred to Tuftsandco@gmail.com Please indicate on the memo line which campsite # the payment is for.
